Regulatory & Advocacy

WiWA stepped in to help members CST and Buell, who were attempting to build a new tower for Verizon in the town of Big Flats, WI. The town had an 18 month, quasi moratorium in place, as they sought to implement a new zoning ordinance that had more to do with agricultural issues. With the expert guidance provided by PCIA's Alex Reynolds, WiWA provided a letter of support for the new tower. Regulatory

Committee member Rod Carter led the successful approval of the new tower and construction began in March.

 WiWA and the PCIA have also been working with CST on a new AT&T tower near the Bad River Indian tribe in northern WI. Issues include historic burial sites and the tribe's desire to generate new revenue. PCIA's Zac Champ has been working with the FCC to try to facilitate a solution

WiWA exhibited at the annual conference of the Wisconsin League of Municipalities on October 17. WiWA interacted with over 40 municipalities, emphasizing its mission of education and advocacy, and pitching a model zoning ordinance and Wireless 101 opportunities. Discussion topics included use of narrower cable to improve capacity, water tank collocation, zoning ordinances, and tower mods.
