The **Regulatory Committee** meets once a month to discuss issues that impact the wireless industry. The purpose is to stay abreast of regulatory and legislative issues that affect wireless development on a national, state, and local level. In addition to monitoring these issues, the Regulatory Committee will take action independently, or through help from our friends at PCIA, and contact state and local agencies to try to influence decisions on matters affecting development.

On the 3rd Thursday of the month, the Regulatory Committee holds a conference call at 3 pm CDT to discuss these issues, educate each other, and help

each other solve regulatory issues, most commonly on a local level. Committee members and participants on the call represent many of the businesses (vendors, carriers, tower companies) doing business in Wisconsin and neighboring states. Also joining the call each month are members of PCIA who are proving to be a tremendous source of information and influence on state and local issues.

Examples of recent meeting topics include the Obama Administration's wireless broadband initiative, ways to streamline local regulation of co-locations through state legislation, how to prevent the spread of CMS (Center for Municipal Solutions), and annual

permitting fees.
